A RESOLUTION RATIFYING THE MAYOR'S SUBMISSION OF EXHIBIT E FOR THE LORAIN COUNTY SOLID WASTE AND RECYCLABLES COLLECTIONS CONSORTIUM AND DECLARING AN EMERGENCY.

WHEREAS, certain political subdivisions have organized to provide a collective competitive bidding opportunity to political subdivisions for securing solid waste and recyclable material collection and disposal services; and

WHEREAS, the political subdivision members of this group are referred to as the Lorain County Solid Waste & Recyclables Collections Consortium; and

WHEREAS, the City of Avon Lake is a member of the Lorain County Solid Waste & Recyclables Collections Consortium and Council has reviewed the Mayor's Exhibit E.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF AVON LAKE, STATE OF OHIO:

<u>Section No. 1:</u> That Council hereby confirms, adopts, and ratifies the Mayor's Exhibit E for the Lorain County Solid Waste & Recyclables Collections Consortium.

Section No. 2: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section No. 3: That this Resolution is hereby declared to be an emergency measure, the emergency being the necessity of adopting and ratifying the Mayor's Exhibit E in a timely manner, thus for the health, safety, and welfare of the public. Therefore, this Resolution shall be in full force and effect immediately upon passage and approval by the Mayor.

The Contractor shall provide permanent collection containers to the City at the following locations at no additional charge to the City:

- Avon Lake Service Department, 750 Avon Belden Road, Avon Lake, Ohio: one (2)-cubic yard dumpster and three (8)-cubic yard dumpster for Solid Waste, and one (8)-cubic yard dumpster for Recyclable Materials;
- Avon Lake Safety Center, 32855 Walker Road, Avon Lake, Ohio: one (8)-cubic yard dumpster for Solid Waste, and one (8)-cubic yard dumper for Recyclable Materials;
- Avon Lake City Hall, 150 Avon Belden Road, Avon Lake, Ohio: one (5)-cubic yard dumpster for Solid Waste;
- Miller Park Boat Launch, 33760 Lake Rd., Avon Lake, Ohio: one (8)-cubic yard dumpster for Solid Waste;
- Ellen Trivanovich Aquatic Center, 32850 Electric Blvd., Avon Lake, Ohio: one (8)-cubic yard dumpster for Solid Waste, and one (8)-cubic yard dumper for Recyclable Materials (Collection once a week October through April and three times a week May through September);
- Avon Lake Municipal Facilities, 201 Miller Road, Avon Lake, Ohio 44012:
 - Administrative Offices, one (8)-cubic yard dumpster for Solid Waste, and one (8)-cubic yard dumper for Recyclable Materials;
 - Water Treatment Plant, one (8)-cubic yard dumpster for Solid \Waste;
 - Wastewater Plant, one (8)-cubic yard dumpster for Solid Waste, and one (4)-cubic yard dumper for Solid Waste, and one (2)-cubic yard dumpster for Solid Waste

<u>EXHIBIT E</u>

Unless noted differently above, the Contractor shall collect all Solid Waste and Recyclable Materials deposited in the collection containers provided by the Contractor once per week, unless additional collections are necessary at the discretion of the City, at no additional charge. The exact number, size and location of the above collection containers may be modified within reason at the request of the City, with agreement by Contractor.

Contractor shall provide two Unlimited Solid Waste Collection Service pickups to all Residential Units two times each year at no additional charge to the Resident; the Collection Day immediately following the Christmas holiday; and one additional Collection Day to be determined by the City, and coordinated, as practicable, one week in advance.

In addition, the Contractor shall provide open top roll-off containers of up to thirty (30) yards capacity at no additional charge upon request of the City for certain Special Events, up to six (6) special events annually, including without limitation: 1) Fourth of July Celebration at Weiss Field; 2) Lorain County Beautiful Day; and 3) Beer Festival The Contractor will also provide open top roll off containers, the exact number, size and location of the which will be determined by agreement between the City and Contractor for the April 2024 April Eclipse Event. The Contractor and City will coordinate the dates for the Special Events at least one month in advance.

Contractor shall provide open top roll-off containers at the request of the City to the Avon Lake Service Department in the event of natural disaster or a weather related event.

Additional collection containers and pulls may be requested at the price, if any, indicated on the Bid Form.
