AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT WITH ENTERPRISE FLEET MANAGEMENT FOR THE LEASING OF CITY VEHICLES AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 22-165 authorized the Finance Director to negotiate a contract with Enterprise Fleet Management for the purpose of leasing City vehicles through Sourcewell Cooperative Program; and

WHEREAS, the Public Works Director has recommended the City continue with the vehicle replacement program to lease 11 vehicles from Enterprise Fleet Management; and

WHEREAS, the Finance Director has requested authorization to enter into an agreement with Enterprise Fleet Management to lease 11 vehicles for the Public Works Department for an annual amount not to exceed \$187,000.

> NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON LAKE, STATE OF OHIO:

<u>Section No. 1:</u> That the Mayor is hereby authorized and directed to enter into a lease agreement, as approved by the Law Director, to lease 11 vehicles (Exhibit A) on behalf of the Public Works Department with Enterprise Fleet Management through the Sourcewell Cooperative Program for an annual amount not to exceed \$187,000.

Section No. 2: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section No. 3: That this Ordinance is hereby declared to be an emergency measure, the emergency being the necessity of providing City departments with safe and reliable vehicles in order that they may promptly, safely, and efficiently perform their duties, thus for the health, safety, and welfare of the citizens of Avon Lake. Therefore, this Ordinance shall take effect and be in full force immediately after its passage and approval by the Mayor.
