



Instructions, Conditions and Procedures

INSTRUCTIONS

1. Permittee must complete all sections of the Municipal Deer Control Permit (MDCP) except where noted “Office Use Only” or “Police Use Only.”
2. Permittee must attach a map of the area/property/parcel(s) to be used for culling of white-tailed deer as indicated in the Location section on Pages 1 and 2 of the MDCP. Include structures, characteristics of property and location of elevated position where shooters will be.
3. Each shooter listed on the MDCP must provide a copy of their Ohio Hunting License and Ohio Hunter Safety Course certificate.
4. Permittee must provide a deer disposal plan that violates no state or local laws. Include plan in the section provided on Page 4 of the MDCP.
5. By signing the Municipal Deer Control Permit, the Permittee, Landowner(s) or Lessee(s) and all shooters accept liability as outlined in the Agreement and Indemnity section on Page 6 of the MDCP.

CONDITIONS/PROCEDURES FOR UTILIZING AN APPROVED MDCP

1. The permit shall be in effect from the Issue Date through the Expiration Date listed at the top of Page 1 of the MDCP.
2. Hours of culling permitted for this parcel are as specified by ODNR rules unless otherwise noted in the Special Instructions/Restrictions section on Page 5 of the MDCP.
3. Permit holders and listed shooters included on the permit must follow all regulations included on both the Ohio Department of Natural Resources Deer Damage Control Permit and the City of Avon Lake Municipal Deer Control Permit.
4. Each shooter must have on his/her person a copy of the permit for the property for which he/she is listed and is shooting on at the time. Upon completion and approval, copies will be provided.
5. A shooter on an Ohio Division of Wildlife Deer Damage Control Permit (DDCP) and a Municipal Deer Control Permit (MDCP) must contact Avon Lake Police Department Dispatch at (440) 933-4567 **at least 24 hours prior** to an attempt to shoot a deer utilizing DDCP and a MDCP.
6. Shooters must shoot from an elevated position unless otherwise noted in the Special Instructions/Restrictions section on Page 5 of the MDCP.
7. If a deer leaves the property covered under the MDCP, the shooter must immediately notify Avon Lake Police Department Dispatch at (440) 933-4567 of the situation.
8. Any deer killed under a MDCP must be reported to the Avon Lake Police Department Dispatch at (440) 933-4567 within 24 hours of tagging the deer.
9. The Chief of Police or designee can revoke or suspend the permit at any time for any reason.

AGREEMENT AND INDEMNITY

THIS AGREEMENT AND INDEMNITY (“Indemnity”) is executed by the persons signing PAGE 3 of this permit (collectively, “Permittees” and individually a “Permittee”) in favor of the City of Avon Lake , Ohio (the “City”), a municipal corporation, and its employees, officials, representatives and agents (collectively, the “Indemnitees”).

1. Permittees are identified as Landowners, Lessees and/or Shooters on Municipal Deer Control Permit Number _____ (the “Permit”) issued by the City, allowing Permittees to kill deer on the property in Avon Lake, Ohio, described on Pages 2 and 3 of this permit.
2. Permittees accept full responsibility for all consequences arising out of the exercise of their rights under the Permit, Permittees, jointly and severally, agree to indemnify, defend and save harmless the Indemnitees from and against any and all claims, actions, demands, damages, liability, losses, cost and expense, including attorney’s and other professional fees: (a) in connection with loss of life, personal injury and/or damage to property arising from or related to, wholly or in part, directly or indirectly, the hunting or killing or attempted hunting or killing of deer or activities related hereto, by any Permittee or (b) arising from or related to, wholly or in part, directly or indirectly, the violation by any Permittee of any term or condition of the Permit, any term or condition of any permit issued to Permittees or any of them by the Division of Wildlife, Ohio Department of Natural Resources, or of any applicable law, statute, ordinance, rule or regulation of the State of Ohio or the City.
